Chief Nestor indicated a warrant was added to the fall town meeting for the repair. The cost of the repair needs to be indicated at the town meeting. The Committee indicated a study is needed to determine the scope of work and construction costs. Mr. Pilibosian will ask the Town Manager if we can get the study done with emergency funds.
