(248-) 378 Purgatory Road (Map 8, Parcel 13)

Proposed repair of a septic system along with requisite grading and utilities within the 100 foot buffer zone. The applicant is Linda Carreau represented by Andrews Survey & Engineering (ASE), 104 Mendon Street, Uxbridge, MA 01569.

Paul Hutnak of ASE explained that this is an existing dwelling that needs an upgrade to the existing septic system.

Cindy Campbell arrived at 7:06PM.

The system will be 32 feet off the wetland and surrounded by a poly-barrier. There will be as minimal disturbance to the area as possible. Once completed, the area will be returned to lawn. The landscape becomes wooded off the property at the back of the lot towards the wetlands. The well is +/-68 feet from the septic. The area is previously disturbed. The Department of Environmental Protection (DEP) has not issued a DEP file number yet.

Motion made by Mr. Ouillette and seconded by Ms. Anderson. The Conservation Commission (NCC) voted 5-0 to continue the Public Hearing to March 23, 2016 at 7:10PM.
