WARRANTS:

MINUTES

It was approved unanimously 4-0 by a roll call vote to close the Public Hearing to hear input to grant a 3% COLA effective July 1, 2019 for the eligible retirement members.

Neil Vaidya made a motion to grant a 3% COLA effective July 1, 2019 for all the eligible retirement members. The motion was seconded by Sharon Susienka.

The Board voted unanimously 4-0 to grant a 3% COLA effective July 1, 2019 for all eligible retirement members.
