- Emilee Angell- The Spring concert is on April 5th and Evening of the Arts is on April 11th.
- Brian Paulhus- Spring Sports are underway; the kids are waiting to get outside on the fields.
- Alicia Cannon- Thank you to all of the parents and teachers that reached out to her, it was good to hear from people and she hopes that continues. Alicia stated that we have heard a lot that we have not heard in the past and it's important for everyone in this town to realize that elected officials are here for you. They are elected by the town regardless of whether anyone runs against us or we run unopposed that's what we are here for. If we do not get the feedback, we can't do anything about it. Alicia stated that she attended the Class of 2019 funny with funs and they did a great job and raised a decent amount of money for their class.
- Joe Strazzulla- Echo's the comments made by Alicia. The first year Joe came on board was the meeting that we had to make significant cuts. That was the worst meeting he has had to sit through. The overwhelming community voice that we have heard in the last two weeks is refreshing because it is what we need in this town. Joe agrees with Mike that this is a revenue problem and it will have to be addressed in the coming years. We have the School Building project in which Joe is the chair for coming online. It is a one hundred million dollar project, with a 55 million dollar town share after eligible reimbursements. This will come before the town as well to vote on. We will have to come together as a town to support that project as well as any other revenue deficiencies.
- Catherine Stickney stated that the Celebration of Learning is also on April 11th. Cathy is also pleased to announce that we have received 65 applications for the Career/Nicholas Academy.
- Michael LeBrasseur thanked everyone, as mentioned we will be presenting our updated budget to Fincom tomorrow evening.
