NPS is a busy place! Our seniors are finished classes and taking finals. It is hard to believe that we will be celebrating graduation next Friday night!

Cathy was fortunate enough to be one of five superintendents from Massachusetts invited to represent M.A.S.S. at an International Conference for Global Studies at Harvard two weeks ago. Sixty-six countries were represented, including numerous dignitaries and ambassadors from around the world. Two hundred and fifty people were present, and 2,500 people were watching the conference on live stream. Our goal is to articulate competencies for global education that transcend any cultural or linguistic barriers. Cathy plans on sharing this work with our staff, because it is relevant to the work we are doing in our community. This work is also timely as we continue to participate in programs with students and faculty from China.

Carissa Letendre and Christopher Sullivan graduated from the BVYLA on May 9th. They were honored at a ceremony with participants from other communities. We recognized Carissa for her wheelchair swing project. Christopher will join us for an upcoming meeting.

We have inducted students into National Art Honor Society and Tri-M National Music Honor Society for next school year.
