a. Independent Review of the Special Education Department

Michael LeBrasseur stated that we reviewed and agreed on the scope of services at the last SC meeting. We needed three proposals as it is anticipated that the cost will exceed \$10,000. The committee will meet on 5/11/18 to discuss the proposals.

b. Special Education Data

Catherine Stickney discussed and clarified the data that was presented at the last SC meeting.

c. School Security

Catherine Stickney stated that we have had community members reach out to assist with school security with items such as AED's and metal detectors. Dr. Stickney has reached out to the principals for their school needs and will be putting together a security committee to assist with these discussions/decisions.

d. School Committee Policy Review EFD

Since the last SC meeting, Dr. Stickney has spoken with other districts such as Douglas and Uxbridge. Their policies are similar to the direction we would like to go. We have received information and an offer for donations, from the community, to assist us in covering the negative feed balances. The group has asked that students follow our regular procedures; students that fall below the \$11.00 balance will still receive a complete lunch. We will observe data at the end of the school year. A fund will be set up to pay for this balance. This is a pilot program.

e. Superintendent Summative Evaluation Process

Catherine Stickney discussed the Superintendents Summative evaluation.

f. School Building Committee Update

Michael LeBrasseur stated that the schematic design was submitted yesterday. June 27th is the next step-MSBA vote. The Mason Road Neighbors meeting will take place on May 19th, at 3pm. There will be a larger neighborhood meeting as well. They had a great joint meeting last night.
