Patrick Smith advised he has 4 children in the school system and last time he spoke during public comment he provided a 38 page legal complaint stating neither the superintendent, school committee, or DESE had the legal authority to force face masks on children. He asked two questions regarding the district's dependency on funding in relation to face masks. Steven Falconer advised that the questions were sent to DESE. Patrick was there to provide a 12 page document from a journalist from Quincy regarding the negative impacts of face masks on children.

The Student Representative did not provide a report this evening, as he was involved in athletics.

VIII. Superintendent's Report

Superintendent Amy McKinstry provided an update on the current progress at NES including that the playground for the upper grades is set to be completed next week and the main parking lot or preschool pic up and drop off lot will be completed in November and was slowed down due to weather. Picture days will start on Wednesday, October 13th. The middle school held assemblies regarding Tik Tok challenges around the country and students were receptive and understanding. The middle school recently started an advisory club to discuss important issues and their first meeting, which had over 40 students in attendance, was October 6th. The middle school will be sponsoring their first family movie night and showing Hocus Pocus on a giant inflatable movie screen. The school will also be providing extra support in ELA and math on Tuesdays and Thursdays, and students with low grades have been invited to join. The PSAT and SAT exams will take place at the high school tomorrow, and throughout the month different colleges will be visiting every day. Freshman academy students have been working on thinking about career paths. The high school just recently held their 3rd dress code committee meeting. In general, there are still families that have not yet sent in the beginning of the year paperwork and test and stay program is now up and running. The numbers at the high school are rising daily with 14 positive and 136 close contacts. A large group of them are doing test and stay and 79 are vaccinated. Amy also provided an athletics update.
