I. <u>APPROVAL OF MINUTES:</u> The minutes of the September 13, 2016 meeting were approved. (Farley, Beneway).

II. DISCUSSION ITEMS AND PROGRESS REPORTS

Note: The Trustees agreed to rearrange the agenda to accommodate the busy schedules of our guests.

A. R.F.P. ROCKDALE WWI MEMORIAL RFP

- Robert Shure presented his draft RFP to the trustees, reviewing the complete document and answering any questions the trustees had pertaining to the document.
- Mr. Shure noted that it was important that specialized companies that are qualified to do this type of reconstruction and restoration work be identified.
- He also noted that revisions to this document should be made to accommodate historical commission recommendations as well as the concerns of the trustees and the town.
- <u>ACTION:</u> Robert Shure showed the trustees several pictures of granite that could be used to replace the concrete used on the deck of the monument. The motion was made and seconded that we use "Chelmsford Grey" for this work. Unanimously approved.
- The trustees thanked Mr. Shure for his fine work noting our commitment to get any changes to him as soon as possible.

B. MEMORIAL PARK LANDSCAPING

- Dan Beneway introduced Nick Jane' to discuss his recommendations for improving Memorial Park in Whitinsville.
- Nick noted that overall the landscaping of the park needed to be simplified. Nick was happy to work with us on recommendations and would visit with Bob Fitzgerald, the Town Assessor, to see if any blueprints were available pertaining to the site.
- He also noted that any recommendations for changes would be reviewed with the DPW in order to meet their needs as well.
