- 25-feet from an abutting property line
- 100-feet from any swamp, stream, pond, or drainage easement
- 100-feet from any abutting dwelling
- 100-feet from any private drinking water well

Attach certified plot plan showing type & location of any structure within 200 ft. of stable and corral – be sure to show any streams, swamps, ponds, on-site sewage disposal systems, private wells and occupied dwellings. Said plan shall note all distances between each structure, sewage system and well.
