BOARD OF SELECTMEN'S MEETING November 23, 2015 AT 7:00PM

A meeting of the Board of Selectmen was called to order by Chairman Thomas Melia at 7:00 PM, Northbridge Town Hall, 7 Main Street, Whitinsville, MA. **Present:** Messrs. Ampagoomian, Nolan, and Melia. Selectman Marzec and Selectmen Athanas were absent and it is duly recorded. **Also Present:** Theodore D. Kozak, Town Manager

The Pledge of Allegiance was recited by those present

APPROVAL OF MINUTES 1) November 9, 2015 [Executive Session] A motion/Mr. Ampagoomian seconded/ Mr. Marzec to approve but not release the November 9, 2015 Executive Session Minutes. Vote yes/Unanimous.

PUBLIC HEARINGS: 7:05 PM: Massachusetts Electric Company / Petition for new Pole and Pole Relocation (Pollard Road): N'Grid requests to relocate pole # 8 to clear the Kinder Morgan Tennessee Gas Line and install pole # 8-50 for line span and relocate pole # 9 also for line span. Present: Crystal Tognazzi Chairman Melia read aloud the public hearing notice. A motion/Mr. Ampagoomian, seconded/ Mr. Nolan to open the public hearing. Roll call vote: Mr. Ampagoomian/Yes, Mr. Nolan/Yes, Mr. Melia/Yes. Ms. Tognazzi stated pole 8 was too close to the Tennessee Gas Line which is why National Grid is requesting to move pole 8, 27 feet off of the Tennessee Gas Line. National Grid is also suggesting a mid-span pole of 8-50 to shorten the span length between 8 and 9. No abutters were present. A motion/Mr. Nolan seconded/Mr. Ampagoomian to close the public hearing. Roll call vote: Mr. Ampagoomian/Yes, Mr. Nolan/Yes, Mr. Melia/Yes. A motion/Mr. Nolan, seconded/ Mr. Ampagoomian, to approve National Grid's request for new pole 8-50 as presented. Vote yes/Messrs. Ampagoomian, Nolan, and Melia. Mr. Ampagoomian asked Ms. Tognazzi if someone from National Grid could provide an update on the pole on Church Street. Highway Superintendent Mr. Luchini explained that he believes it had been removed last week.

CITIZENS' COMMENTS/INPUT - Local Business Spotlight: Little Man Originals - [Present: Christine Guanipa, Proprietor] Jeannie Hebert, president and CEO of Blackstone Chamber of Commerce. introduced Christine and Miquel as the owners of Little Man Originals which is located on Church Street. Mrs. Guanpia is also the Chairmen of the Shop Small Committee. Everything is made at the store and is made to order. Mr. and Mrs. Guanipa moved to Whitinsville 10 years ago and are both graduates of Mass College of Art, Mrs. Guanipa a Print Making Major, and Mr. Guanipa a Cartoonist. Mrs. Guanipa turned to designing hand bags and used Mr. Guanipa's cartoons which became the logo. Little Man Originals do wholesale, and design a collection every year of hand bags, and accessories and travel to sell them. Today they have products in over 200 stores and galleries. The Shop Small campaign is conducted of about 24 small shops which is scheduled for Saturday November 28, 2015 from 10 AM to 5 PM. The purpose of the Shop Small Campaign is to bring people back into Northbridge. There will be a shuttle provided by Alternatives for those interested which will be going around Town making 5 stops and looping around town, and red chairs and balloons will be out front of participating stores. Mrs. Guanipa showed off some of the items for sale in her shop of which included large bags, accessory bags, wristlets, wallets, change holders, as well as bibs. Mrs. Guanipa told the story of how one day she received a call from the Senator who found their products online and from there they designed fabric for the White House which include donkeys and elephants and they continue to receive orders from the White House. The store hours are Wednesday thru Friday from 10 AM - 5 PM and Saturday from 10 AM - 2 PM. Visit them online at littlemanoriginals.com. Mrs. Guanipa also does private parties, and studio events with visiting artists.

Pine Grove Cemetery/Vote to accept American Flag donated by Mary Bedoian A motion/Mr. Ampagoomian, Seconded/Mr. Nolan, to Accept the American Flag to be flown at Pine Grove Cemetery. Vote yes/Messrs. Ampagoomian, Nolan, and Melia.

Friendly Discount Liquors, Inc. d/b/a Friendly Discount Liquors [Sook L. Huynh, Mgr.] / Request to prorate the Annual Liquor License fee Manager Sook Huynh the new manager of Friendly Discount Liquor requested the Board pro rate their ABCC approved Liquor License fee for the remainder of 2015. A motion/Mr. Ampagoomian, seconded/Mr. Nolan, to approve the request of the pro-rated fee for Friendly Discount Liquor's 2015 license for 1 month. Vote yes/Messrs. Ampagoomian, Nolan, and Melia.

Pine Knoll Sub-division / The Board of Selectmen shall vote to: 1) Approve the agreement for donation of funds with Aris Group, LLC in connection with the Planning Board's September 22, 2015 modification of the Special Permit for the Pine Knoll Senior Living Development 2) To approve the Planning Board's expenditure of the donated funds for the purpose of the preparation of a Housing Production Plan and an Open Space & Recreation Plan for the town. Town Planner, Gary Bechtholdt was present to describe the details of the request. The Selectmen are asked to formalize the agreement that was reached through a variance from the Zoning Board of Appeals, waiving the requirement for the 3 affordable units. It was required to go back to the Planning Board to modify the Special Permit. As part of the Special Permit modification the owner, applicant, and Planning Board came to the decision in lieu of and exchange for the 3 affordable units they would provide a one-time donation to the Town as established through the special permit. The fund will be used to hire a consultant for the preparation of a Housing Production Plan as well as an Open Space and Recreation Plan. The remaining funds will be decided upon by what the Planning Board wished to do with then will be presented to the Board of Selectmen to be voted on. A motion/Mr. Ampagoomian, seconded/Mr. Nolan, to vote to approve the agreement for donation of funds with Aris Group, LLC in connection with the Planning Board's September 22, 2015 modification of the special permit for the Pine Knoll Senior Living Development and to approve the Planning Board's expenditure of the donated funds for the purpose of the preparation of a housing production plan and an Open Space and Recreation plan for the Town. Vote yes/Messrs. Ampagoomian, Nolan, and Melia.

Winter Parking Ban [December 1, 2015 to April 1, 2016] / Vote to approve There were no changes from last year's parking ban. A motion to approve/Mr. Ampagoomian, seconded/Mr. Nolan to approve the Winter Parking Ban as presented. A Vote yes/Messrs. Ampagoomian, Nolan, and Melia.

National Park Designation / Present: Kenneth Warchol, Meghan Kish, Superintendent, and Jennifer Smith, NPS Director Meghan Kish, Superintendent of the Northbridge National Park as well as other National Parks gave an overview on the designation. December 19, 2014 the Blackstone River Valley National Park became the 402nd National Park. In the Legislation, there are 6 nodes and Whitinsville is one of them. It is Ms. Kish's responsibility to set the boundary for the new park. It includes Slater Mill in Pawtucket, the Kelly House in Blackstone State Park as well as Slatersville and Ashton RI, Hopedale and Whitinsville. Prior to getting in to the National Historic Park the Town needs to be in boundaries set and the Commission prepared to oversee the preservation of the buildings. The Town needs to reestablish the Local Historic District Study Committee which is a 7 member Committee. The boundaries are already proposed and the next step would be to go to a public hearing and then Town Meeting. Being in the boundary allows the investment of resources which is an incentive toward moving forward with this. Meghan Depreat who works with the Heritage Corridor will be helping through the project. She is the Deputy Director of the Blackstone River Valley National Heritage corridor which includes 25 communities in total. She is hopeful that this is something the community is interested in and will always be happy to help out on all areas of the process.

Aldrich School Fence / Present: Kenneth Warchol, Chairman of Northbridge Historic Commission Mr. Warchol, Chairman of the Northbridge Historic Commission spoke regarding the removal of the Aldrich School Fence. Mr. Warchol asked for approval to take down the fence in front of the Grammar Schools because it is one of the most beautiful squares which the fence blocks and since there is no longer a school there it would make sense to remove the fence to reveal the historical look. A motion/Mr. Nolan, seconded/Mr. Ampagoomian to move item H. Aldrich School Fence from discussion to decisions. Vote yes/Messrs. Ampagoomian, Nolan, and Melia. A motion/Mr. Nolan, seconded/Mr. Ampagoomian to approve the removal of the Aldrich School Fence.

Chairman Melia verified that it would be completed under the Town Highway Department. Vote yes/Messrs. Ampagoomian, Nolan, and Melia

TOWN MANAGER'S REPORT 1) Aggregation Bid Results - Attended the bid opening for the electricity aggregation, which involves 23 Communities. The low bid by Cond Edison came in at 9.49 Cents and will go into effect in January for 24 months, for comparison purposes, National Grid's winter rate is 13.1 cents. A letter will be sent to all home owners in Town who have National Grid as their supplier, which describes details regarding the program. Customers will automatically be enrolled into the program but will have the opportunity to opt out of the program. Any customers who are currently with a different supplier must first opt out of the current program, firstly making sure there are no fees to end the contract. Once a customer has ended that supplier contract they may opt into the Con Edison program with the Town. 2) Veterans Day Services - Attended Veterans Day services and the dedication for Cpl. John Dawson. Despite the bad weather the event was well-attended and beautifully done by the Trustees of Soldiers' Memorials. 3) Stormwater Update - Attended a Regional Stormwater meeting and discussed plans for next year's EAP requirements by the government. 4) WRTA Bus **Program** - The WRTA provided the Town with updated ridership numbers and it shows that the program is still picking up passengers so they will continue to go forward with the bus program. 5) Senior Center Luncheon -Attended a luncheon sponsored by Senator Michael Moore and the Blackstone Valley Chamber of Commerce. They served a turkey dinner and desert to over 100 people, which was a large increase over last year. Town Manager Kozak announced the Fire Truck is read and we should be receiving it within the next two weeks.

SELECTMEN'S CONCERNS Mr. Ampagoomian 1) Charter Communications reception has been deplorable, Pixilation, advertisement to upgrade, it freezes, and shuts down. Mr. Ampagoomian suggested that anyone who is having these issues call Northbridge Community Television and suggested a letter campaign to our senators since the fees continue to rise and it is bad service to begin with. Mr. Nolan 1) Congratulated the Northbridge High School football team and wished them luck at the Super Bowl in a couple of weeks. Mr. Melia 1) stated that the dedication ceremony of the Cpl. Dawson monument was a very moving ceremony, and the Soldiers' Memorial Committee did an excellent job.

Chairman Melia announced the next Selectmen's agenda is scheduled for December 7, 2015.

A motion/Mr. Ampagoomian, seconded Mr. Nolan to adjourn the meeting. A Vote yes/Messrs. Ampagoomian, Nolan, and Melia.

Subject: Six Month Report

This is a summary of the fire department activity from July 1, 2015 through December 31, 2015. The fire department responded to 452 fire emergencies, 997 ambulance emergencies, 50 non-emergency calls for service, visited the schools to conduct SAFE classes 40 times, and installed smoke and carbon monoxide detectors in the homes of 25 senior citizens. Overall, this program has been very successful with the firefighters visiting and installing detection devices in the homes of 32 seniors. In addition to this, fire prevention activities accounted for 459 inspections, 289 permits issued, conducted 16 fire drills, and collection of \$ 11,640.00 in permit fees. Of the 997 ambulance emergencies, there were 646 ALS calls and the ambulance service collected \$ 392,811.36.

During this period we had 5 structure fires, 8 motor vehicle fires, and 23 outside fires. The fire losses to the affected properties will exceed \$ 300,000.00. We responded to fires in other communities 12 times under our mutual aid agreements, and received mutual aid for fire and EMS incidents 69 times. The call fire and ambulance payroll for this period was \$ 51,754.36.

In June we transitioned over to the new Public Safety Dispatch Center at the police station. This has allowed the department to provide an additional eighty-four (84) hours of coverage during the hours of 6:30 a.m. and 6:30 p.m.

In September we received bids for a new ambulance which was approved by the voters at the May Town Meeting. The new vehicle should be available in the spring or early summer of 2016.

We took possession of the new ladder truck in November and the personnel have been training and placing the equipment on the vehicle. In early December we received two (2) days of intensive training from a factory representative. We will be receiving two (2) more days of factory training in the spring.

We are currently working with FEMA to recover some of our costs for the January 26, 2015 snow storm.

INTERMUNICIPAL AGREEMENT REGIONAL SYSTEMS ADMINISTRATOR SERVICES

This Intermunicipal Agreement (hereinafter "IMA") is entered into as of
, by and between the Town of Northbridge, a Massachusetts municipal
corporation, by and through its Board of Selectmen, 7 Main Street, Whitinsville, MA
01588 (hereinafter "Northbridge") and the Town of Douglas, a Massachusetts municipal
corporation, by and through its Board of Selectmen, 29 Depot Street, Douglas, MA
01516 (hereinafter "Douglas"), in accordance with G.L. c. 40, §4A as follows:

WHEREAS, Northbridge currently employs a full time Systems Administrator for computer systems configuration, operation and maintenance; and

WHEREAS, Douglas currently has no Systems Administrator; and

WHEREAS, Northbridge and Douglas are desirous of making the most efficient use of community resources while maintaining sound community services.

NOW THERFORE, for good and valuable consideration, and the mutual promises set forth below, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. **REGIONAL SYSTEMS ADMINISTRATOR:** Scott Motyka, or his/her successor employee with Northbridge, will serve as the Regional Systems Administrator (hereinafter "Regional Systems Administrator") in both Northbridge and Douglas.
- 2. OPERATIONS: The Regional Systems Administrator will report to the Town Manager in the Town of Northbridge on a day to day basis and as required by the Town of Northbridge for all systems administration duties associated with the Town of Northbridge, and the Regional Systems Administrator will report to the Town Administrator in the Town of Douglas on a day to day basis and as required by the Town of Douglas for all systems administration duties associated with the Town of Douglas, subject to the following terms and conditions:
 - a. The Regional Systems Administrator shall be available to the Town of Douglas for 20% of his regularly scheduled work hours during the term of this Agreement. The schedule shall be set, and may be modified, by mutual agreement of the Northbridge Town Manager and the Douglas Town Administrator.

- b. The Regional Systems Administrator shall make any and all financial and operational reports as required by the Northbridge Town Manager and the Douglas Town Administrator.
- **3. BUDGET**: The Regional Systems Administrator will maintain separate budgets and operating systems for each community.
 - a. The Town of Douglas shall pay the Town of Northbridge at the rate of 20% of salary and benefits attributable to the position of the Regional Systems Administrator, subject to the other provisions of this section. The rate for successive years shall be reviewed, negotiated, and established by the Towns, by mutual agreement, by February 1st of each year.
 - b. The Town of Douglas shall pay its 20% share to the Town of Northbridge on a quarterly basis on the first day of each quarter. On June 30 of each fiscal year, a final bill shall be presented by Northbridge.
 - c. The Town of Douglas shall pay the IRS standard mileage rate for miles driven by the Regional Systems Administrator from the Town of Northbridge to the Town of Douglas and back.
- 4. LIABILITY: Each party shall maintain appropriate general liability insurance to cover the Regional Systems Administrator while the Regional Systems Administrator is performing his/her duties in the respective Town. For purposes of liability insurance, the Regional Systems Administrator shall be considered an employee of the Town for which he is acting during the performance of his/her duties for that respective Town. As the Regional Systems Administrator is a full-time employee of the Town of Northbridge, the Town of Northbridge is responsible for maintaining Workers' Compensation, income tax withholding and employee benefits.
- **5. TERM**: This Agreement shall take effect on _____ This Agreement shall continue in effect for:
 - a. For one (1) year with two renewal options of one (1) year each. The renewal period shall be exercised no later than four (4) months prior to the end of the current term, or
 - b. until one of the parties hereto provides at least four (4) months notice prior to the start of a new fiscal year that it does not intend to participate in this Agreement for the upcoming fiscal year ("Notice of Termination"), or
 - c. if the Regional Systems Administrator leaves the employ of the Town of Northbridge, the Town of Douglas shall have the opportunity to provide two (2) months' notice that it will terminate the Agreement if Northbridge does not provide continuation of the service suitable to the Town of Douglas.

6. **DEFAULT:** Should any party hereunder fail to provide said Notice of Termination as set forth in section 5 (b) above, or fail to maintain the appropriate insurance as required hereunder or in any way violates the terms of this agreement or fails to pay when and as due as required herein, then that party shall be considered in default hereunder, entitling the non-defaulting party to terminate the Agreement upon twenty (20) days written notice. In addition, the defaulting party shall be responsible to the other party for one and a half times any amounts due hereunder for the remainder of the fiscal year.

7. MISCELLANEOUS:

- a. Amendment: This Agreement may only be amended or modified by written document signed by a majority of the Board of Selectmen in each Town.
- b. Fiscal Year: The term Fiscal Year hereunder shall be that of a Massachusetts Governmental Unit July 1 to June 30.
- c. Governing Law: This Agreement shall be governed in accordance with the law of the Commonwealth of Massachusetts and any dispute hereunder shall be directed to the appropriate court in Worcester County.

- 1) <u>Local Historic District Study Committee to Resume</u> The Town is in need of additional individuals for the Local Historic District Study Committee. - 2) <u>Public Safety Appreciation Day</u> An event was held at Wal-Mart on Wednesday December 30, 2015, to celebrate the Town's new ladder truck and the public safety personnel. The event, sponsored by Walmart, was open to the public and was very well attended.
- 3) <u>Library Grant Award</u> The Library was awarded a \$7,500 grant from the Mass. Board of Library Commissioners to enhance pre-school programing, STEM science, and technology. The library will be using the funds to provide programs to the residents in Town.
