# **TOWN MANAGER'S REPORT – JANUARY 7, 2013**

- 1) Town Hall Update: A contract has been awarded for the window repair work and the work will begin shortly.
- 2) Sutton Street Update: Public hearings are being held for tree removal and letters have gone out to homeowners requesting permission to allow temporary and permanent easements.
- 3) Double Poles: Contacted National Grid for an update on the progress of the removal of all double poles. Currently 18 locations are outstanding and there will be a joint meeting with National Grid, Verizon and Charter Communications to implement.
- 4) Mass. Municipal Association Conference: Reminder that the Town Manager and Board of Selectmen will be attending the MMA Conference on January 25<sup>th</sup> and 26<sup>th</sup>.
