If a Police Officer is out of work because of injury/sick, use vacation time before sick time. Town enacts Family Medical Leave Act [FMLA] to protect employee. The Town's Personnel Policy Manual states the employee has to use vacation time first, saves money to Town, because we need to have people fill the shifts. FMLA is to protect both employee and Town. Town can dictate an employee to take FMLA. This discussion will need to go to the Personnel Board to review current policy and modify to reflect current conditions. Suspend 7.56 of Personnel Policy Manual to allow time for the Personnel Board to meet, discuss, review and change as they deem appropriate. Discussion continued that Police never followed current policy, but other departments did. Chapter 30A, S. 21 #3 – Strategy with respect to Collective Bargaining – not to reconvene in Open Session. Present: Messrs. Nolan, Athanas, Melia, Ampagoomian and Marzec. Also present: Theodore D. Kozak, Town Manager and Gary A. Nestor, Fire Chief.

M.G.L. Chapter 30A, S. 21 #3 - Strategy with respect to Collective Bargaining (Fire Dept.)
Town Manager Kozak went to Boston to meet with the state mediator to try to work out an agreement with the Firefighters Union. He explained to the Board that for the last two years he has tried to get the Firefighters on the 75%/25% Health Insurance split that the other town employees are currently paying in exchange for a 3% wage increase for each of those years. In addition, the Town Manager also wanted to institute a 15-mile residency requirement. The open issue was guaranteed overtime. The resolution was to have full-timers called in for the first eight days and part-timers after that for up to six months. After that time, overtime would get split between the full-time and call firefighters. Other items bargained were: 1) a \$50 increase for tuition and clothing reimbursement; 2) a \$5 increase for ambulance calls; 3) Probationary period would extend until training period is completed. An agreement was reached by both sides.

In the future, drug testing for Fire, Police, and DPW employees will be put on the table.
