Re:

We have submitted to Northbridge Planning Board (the "Board") a plan entitled "Plan of Land for Castle Hill Road in Northbridge, MA 01588" dated July 28, 2022 (the "ANR Plan"), and we have requested that the Board endorse the ANR Plan pursuant to G.L. c.41, §P. The property shown on the ANR Plan (the "Property") is identified, by the records of the Northbridge Assessor, as Parcel 1 and Parcel 4 on Northbridge Assessor's Plat 3, and Parcel 33 on Northbridge Assessor's Plat 4. A copy of: Northbridge Assessor's Plat 3; Northbridge Assessor's Plat 4; and the "Property Record Card" for each of the three above-referenced parcels is enclosed.

You have noted that the Property, as shown on the ANR Plan, does not separately depict the boundary of each of the three parcels that comprise the Property according to the records of the Northbridge Assessor, and you have requested information or an explanation of why that is the case. I note that the Property Record Card for each of the three above-referenced parcels refers to the same Deed recorded with Worcester District Registry of Deeds in Deed Book 11750, Page 360, a copy of which is enclosed. I also confirm, that as a result of a diligent search of the records of Worcester District Registry of Deeds, we find no Deed or Plan that describes the Property as comprising separate parcels, and certainly no such Deed or Plan that describes separate parcels that are consistent in size and location with the parcels shown as Parcel 1 and Parcel 4 on Northbridge Assessor's Plat 3, and Parcel 33 on Northbridge Assessor's Plat 4. We therefore can not explain why the Northbridge Assessor's Plats depict such separate parcels, but we are confident that the Property, as shown on the ANR Plan, is consistent with the various Deeds and Plans relating to the Property that are of record with Worcester District Registry of Deeds.
