Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions of the Open Meeting Law, MGL Chapter 30A Section 18 and the Governor's March 15, 2020 Order concerning imposition on strict limitations on the number of people that may gather in one place, meetings of the Northbridge Community Preservation Committee shall be conducted via remote participation to the greatest extent possible. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings as provided in the Order.

CALL MEETING TO ORDER

Roll-Call Attendance

Recognizing the presence of a quorum Glenn King, Chair called meeting (via ZOOM) to order at 6:30 PM; with John O'Brien, Rainer Forst, Michael Proto, and Harry Berkowitz in attendance (roll-call attendance). Brian Paulus & Barbara McNamee were absent, with two (2) vacancies (Northridge Historic Commission representative and Member at-large). R. Gary Bechtholdt II, Town Planner was also present.

APPROVAL OF MEETING MINUTES

September 14, 2020

Motion was made (M. Proto) and seconded (R. Forst) to approve the September 14, 2020 meeting minutes. Motion was carried unanimously (roll-call vote).

111. COMMUNITY PRESERVATION PLAN (DRAFT)

Committee members acknowledged receipt of draft Community Preservation Plan updated by G. Bechtholdt. Mr. Bechtholdt asked if each representative could present same to their boards/committees for comment and input of proposed goals for community housing; historic resources; open space & recreational use.

- G. Bechtholdt reminded committee members of the scheduled public informational workshop with the Planning Board to be held October 13, 2020 at 7:00 PM (via ZOOM), noting again the original date/time was postponed due to the State of Emergency issued (COVID-19).
- G. King thanked G. Bechtholdt for working on the draft plan and recognized the Blackstone Valley Tribune frontpage article (Friday, September 25, 2020) on the Community Preservation Act within Northbridge, announcing the public informational meeting, at-large vacancy, and seeking public comment on the preparation of the Community Preservation Plan.
- G. King encouraged members to report back to their individual boards and committees to seek input on the draft thus far. G. Bechtholdt recommended in addition to including an overview on the CPA and goals for the funding of future projects, the plan should include review criteria, submittal process, etc. Committee members agreed.
- G. Bechtholdt suggested Committee should look to review goals at its next scheduled meeting and then look to formalize submittal process, timing of applications and review criteria at a subsequent meeting. G. Bechtholdt proposed the Committee may be ready to formally adopt (public hearing) the Community Preservation Plan in December 2020.
