#### XI. Presentation: ELL Program Updates

Cynthia Bourgelas, Patricia James, and Kathleen Perry presented on English Language Learners in Northbridge. They discussed what an English Language Learner is, English as a second language instruction, abbreviations in ELL, and what ESL Instruction is and what it is not. They also discussed Northbridge language learners, the state guidelines for service hours, growth over time, and service gaps based on state mandates.
