II. Discussions:

a. School Building Project Update

Catherine Stickney stated that the deliverables, descriptions, due date, and timeline are included in the packet. The deliverables are as follows: Initial Compliance Certification, Establishment of School Building Committee, Educational Profile Questionnaire, Online Enrollment Projection, Enrollment/Certification Executed, Maintenance and Capital Planning Information, Local Vote Authorization, and Feasibility Study Agreement.

b. School Building Committee Composition

Catherine Stickney shared a proposed timeline for the establishment of the School Building Committee. The timeline includes School Committee discusses School Building Committee (SBC) and timeline; Proposed SBC information is released; Interested applicants submit letter with qualifications to Kristen Ferrante; Letters released in the SC packet for review; SC meeting at 6:00 for interviews; Special meeting to determine the composition of SBC; Vote to "approve" the SBC composition and members; and Submit to MSBA for approval.

c. Superintendent Summative Evaluation Process
Catherine Stickney shared the Superintendents Summative Evaluation with the
Committee. Catherine discussed: Assess Progress Towards Goals, Assess Performance
on Standards, Rate Overall Summative Performance, Evaluator Comments, Performance
Goals, Performance Rating for Instructional Leadership, Performance Rating for
Management and Operations, Performance Rating for Family and Community, and
Performance Rating for Professional Culture.

XI. Special Guest: Senator Michael Moore

Sen. Michael Moore addressed the committee and discussed Ways and Means, Governors' and the House numbers for FY17, Chapter 70 for FY17, Lifting of the Charter School Cap, Foundation budget, and vocational school funding.

XII. School Committee Individual Comments

Randi Zanca- Annie was fantastic- Commended MS for a "job well done".

Joseph Strazzulla- wants to get everyone thinking about the 5-year plan - promoting the budget and building project wise. We need to start thinking about how we are going to communicate that to the public. Share the process with MSBA. We have an obligation to let them know their involvement and where we stand financially between now and 2019. Start a working session/budget subcommittee, and set some benchmark dates.

Kate Tracy-Tomorrow evening at 7pm the Balmer Show Choir/Chorus will be at the MS for their Spring Concert. It may be the last year for the Show Choir as there is not any secured funding for the program for next year.

Catherine Stickney- Understands there may be some level of concern regarding the Open House question earlier in the meeting. However, Catherine contends that there have been thoughtful conversations about curriculum night as it was originally planned. It would look different from a typical curriculum night. It would also encourage families and support. The administrators were very much focused on our core beliefs and encouraging student and family interaction. We will still plan all of our August events with packet pick up and building visits. This was an additional suggestion to allow one more opportunity for parents to come in.
