



WHITIN MACHINE WORKS

Economic Development Strategy: Building, Land Use & Local Zoning Code Assessment

Narrative

Northbridge is a suburban community with a growing population of 15,707 (2010 US Census); situated in the heart of the Blackstone River Valley, Northbridge is located approximately 12 miles south of Worcester, MA and 30 miles north of Providence, RI (via Route 146). The town, made of up several villages (Northbridge Center, Linwood, Rockdale, Riverdale, & Whitinsville) offers an ideal location for business, industry and residence.

Historically, the town has centered around the Whitin Machine Works (circa 1847), a prominent manufacturing company employing thousands during the Industrial Revolution through World War II. Today, the Shop, as its known locally continues to accommodate manufacturing, local business start-ups and incubator space within downtown Whitinsville.

This one thriving complex has been transformed over the years into multiple leasable tenant space owned by Whitinsville Redevelopment Trust Management (WRT -acquired in 1984). As a result of the economic downtown and slow recovery, however vacancy rates have increased in recent years and continue to do so today. Of the 1.1 million square-feet available upwards of 375,000 square-feet is presently vacant or underutilized; a trend the town would like to see improve.

The Technical Assistance grant will (1.) help assess building tenant space & amenities (general assessment) of Whitin Machine Works for the purpose of attracting & marketing new users (job creation/retention) and (2.) evaluate land use & local zoning codes (Northbridge Zoning Bylaw) for the purpose of identifying new zoning provisions for manufacturing, bio-tech & other emerging technologies (expand permitted uses within Industrial zone). The zoning assessment will provide the town with a template to initiate an update (modernization of) its Use Definitions and Table of Use Regulations; promoting economic development within the downtown (Whitin Machine Works) and other similarly zoned properties.

Narrative

The project costs will not exceed the \$10,000 Technical Assistance grant; the TA Consultant shall work directly with the Northbridge Community Planning & Development Office, staffed by a full-time Town Planner and Administrative Assistant. Additionally, WRT Management (mill owner) has partnered with a local private engineering/surveying firm (Heritage Design Group,

LLC) to prepare necessary layout and/or site plans that may be required as part of the initial building assessment.

The scope of service shall include an overview & assessment of the Whitin Machine Works mill complex (tenant space, layout, zoning, available infrastructure, etc); to be completed in partnership with Consultant and engineering firm noted above. The main scope of service for the Technical Assistance grant will be to work with selected Consultant in reviewing the town's existing land use & zoning regulations (Zoning Bylaw) for the purpose of identifying deficiencies and introduce potential new Use Definitions and Table of Use Regulations aimed to promote and permit new emerging businesses (economic development).

WHITIN MACHINE WORKS ASSESSMENT

<u>Deliverables</u>: Overview & Assessment of Whitin Machine Works shall result in the preparation of a tenant space flyer/brochure noting available square-footage, general description of tenant space, site (tenant space layout) & amenities, zoning, permitted uses, and photographs.

To be completed by property owner and local engineering/survey firm, in partnership with TA Consultant and Community Planning & Development Office.

Action items: Conduct site visit of the Whitin Machine Works; meet with owner and local survey/engineer to discuss/review existing tenant uses currently occupying mill (for compatibility of future uses); identify and tour available space (vacant and/or underutilized); review available infrastructure and building amenities (for future new users); and prepare flyer/brochure marketing space. Estimated time to complete 30-45 days

LAND USE & ZONING BYLAW ASSESSMENT

<u>Deliverables</u>: Land Use & Zoning Bylaw Assessment shall result in the preparation of report indentifying land use definitions deficiencies within the Northbridge Zoning Bylaw and recommendations for zoning amendment to expand permitted uses within the Whitin Machine Works (Industrial); promoting economic development for manufacturing, biotech, incubator space, flex-space, & other emerging technologies; a modernization of the town's zoning bylaw.

To be completed by TA Consultant in partnership with the Community Planning & Development Office (Town Planner) and Inspector of Buildings (/Zoning Enforcement Officer).

Action items: TA Consultant shall meet with Town Planner and Building Inspector to review existing zoning and land use regulations; conduct cursory review identify potential land use deficiencies and offer recommendations for zoning amendments; Town Planner shall report to the Planning Board in conjunction with this ongoing initiative; draft recommendations prepared by the TA Consultant shall be presented to the Planning Board by the Town Planner (copy of

same provided to Whitin Machine Works); after review and comments a final report and recommendations shall be prepared by TA Consultant and presented to Planning Board. Estimated time to complete 90 days

Narrative

Northbridge prides itself in promoting the continued use and reuse of its historic mills through zoning and other redevelopment initiatives. The Whitin Mill (circa 1826) and the Linwood Mill (circa 1879) were both recently awarded Preservation Awards from the Massachusetts Historical Commission for adaptive reuse (2009 & 2013 respectively). The preservation and rehabilitation of these abandoned/deteriorated mills were made possible in part as a result of community-wide support, public/private partnerships and local adoption of a Historic Mill Adaptive Reuse zoning bylaw.

Unlike the two mills noted above, the Whitin Machine Works has not been abandoned nor suffered significant deterioration over the years; in fact recently the complex was outfitted with solar photovoltaic panels on its roof. The mill remains an important architectural element of Northbridge (Blackstone Valley) and serves as a vivid reminder of the town's industrial roots, a historically significant contributor during the Industrial Revolution (at the time largest textile machinery facility in the world). This large expansive mill complex spans nearly a third of mile along Main Street in historic Whitinsville, MA.

The Northbridge Board of Selectmen and Planning Board have voiced public support of this initiative. Additionally, WRT Management (owner) and Heritage Design Group (local engineering/survey firm) have agreed to partner with the town (Community Planning & Development Office) on the proposed scope of work.

Narrative

The Assessment of the Whitin Machine Works will result in the preparation of a marketing flyer/brochure promoting the available space within the historic mill complex; to continue and remain a positive contributor for future economic development within Northbridge.

The Land Use and Zoning Assessment report will provide the town with a template to update (modernize) its Use Definitions and Table of Use Regulations to promote economic development within downtown (Whitin Machine Works) and other similarly zoned properties throughout Northbridge; expanding the permitting of new uses (non-residential) within the



Whitin Machine Works (industrial zone) through revised land use and zoning provision amendments will help ensure the Shop continues to attract and support (job creation); business start-ups, flex-space, biotech and other emerging industries within the Blackstone Valley.

Narrative

Upon receipt of the Land Use and Zoning Bylaw Assessment (recommendations) the Planning Board shall consider sponsorship of zoning amendment article(s) in preparation for the Spring Annual Town Meeting (scheduled May 2014). Pursuant to MGL CH 40A SEC 5 the Planning Board shall conduct a public hearing for the consideration of and its recommendation on the proposed zoning amendment articles. The Town of Northbridge (Planning Board) is prepared to sponsor zoning amendment articles identified as the final action items identified in the TA Consultant report. Similarly, the Board of Selectmen is prepared to offer its support of same.
