VALLEY PUB PLAN OF ACTION LETTER

Dear Board Members,

We are Andrew and Stephanie Briere. We own a home here in town on Woodside Drive with our three children. Drew grew up in town on Prospect Street. With Stephanie having been the manager for the last five years, we were excited when we were given the opportunity to purchase the Valley Pub.

We were also very excited to have an outdoor entertainment license. With Covid, we had to figure out the best option for people to enjoy coming to the pub and allowing for people to feel safe. Providing the Patrons with a comfortable setting has allowed for the community to come together in a safe way at a time when everyone needed it the most. We have invested a great deal of money to improve the Valley Pub's outdoor space. This license will allow for everyone to continue enjoying the space and will help us as a business.

We are NOT just live music and parties at the Pub. We are a family, a place where everybody knows your name. One of our bartenders has worked in this building for 14 years! We have had several charity events to benefit families in need from town. We happily donate gift cards to everything that we are asked of. Events like this will be a normal part of our business for years to come. We care about our pub neighbors and their concerns. Had we known about these concerns we could have done so much more before it got to this point. The following is our plan of action to resolve the issues brought forward by those neighbors.

COMPLAINT: Live music outside.

ACTION: We would only request an outdoor license for the months of May through September We would only request Thursday (acoustic only), Friday (rarely), and Saturday. Bands would be cut off at 10pm, earlier then that on Thursdays. We are working with sound engineers to see what products can be used to dampen the sound. We are also looking into the cost of covering the stage to direct the sound into the hillside.

COMPLAINT: Trash in Neighbors yards.

ACTION: The lot is now being picked up every morning. We believe the main cause of trash in Neighbors yards was due to on street parking. We believe no parking signs on street would remedy that problem.

COMPLAINT: On street parking.

ACTION: We believe NO PARKING signs should be put on the street, and vehicles could be towed at the Owners expense. We will cooperate in any way we can with the town to make this happen.

COMPLAINT: Noise coming from the lot at close.

ACTION: We have had several signs made and hung, both on the building and in the lot, to request that patrons respect our neighbors and be quiet leaving. We have added more door staff for the weekends and busier nights to monitor this situation.

COMPLAINT: Motorcycle noise

ACTION: This is a tough one. We all ride motorcycles, and have our motorcycles inspected for their road worthiness, and to verify that they are legal for the road. If a motorcycle passes this inspection then it is deemed compliant for traveling. We cannot be expected to inspect motorcycles that come to the pub for decibel levels. We will however, continue to remind our patrons on motorcycles to be as quiet as possible, and contact police if there are any incidents that need to be addressed.

COMPLAINT: Capacity

ACTION: We have never gone above capacity. Our door guy keeps count. The fire department does regular checks, and we are always in compliance. Unfortunately, a lot of the time, people drive their own vehicles to the pub, which often gives the appearance that we are packed.

In Conclusion, we are very willing to work with the Neighbors, The town and the Police. This entertainment license is our livelihood and our dream. It is a home away from home for many wonderful people and very talented local musicians. A place that we can pass on to our children one day. The Valley Pub is an achievement that we have always dreamed about and are proud and honored to own. We will continue to work with the town and support the community to the best of our ability.

We found the following listed item is still in need of attention with relevant code attached. ** Owner has submitted appointment letter from state line fire for a scheduled appointment on December 20, 2021 to have Ansul system tested, see attached**

- Ansul system in kitchen is expired/missing tag and Hood inspection tag is expired. (50.1.1 The Design, installation, operation, inspection, and maintenance of all public and private commercial cooking equipment shall comply with this chapter and NFPA 96, standard for ventilation control and fire protection of commercial Cooking operations). (50.5.2.1 Maintenance of the fire-extinguishing systems and listed exhaust hoods containing a constant or fire -activated water system that is listed to extinguish a fire in the grease removal devices, hood exhaust plenums, and exhaust ducts shall be made by properly trained, qualified, and certified person(s) acceptable to the AHJ at least every 6 months).
- 2. Extension cord from inside running out through marked exit door. (<u>11.1.5.6</u> Extension cords shall not be used as a substitute for permanent wiring). (<u>4.4.3.1.1</u> In every occupied building or structure, means of egress from all parts of the building shall be maintained free and unobstructed). ** *This was removed and rectified immediately by Bartender on duty***
