# MINUTES OF MEETING

November 8, 2018

## PUBLIC HEARING: (12-SP-18) Dennis Latour, Applicant:

This public hearing was held on the petition of Dennis Latour, 88 Linwood Ave., Whitinsville, MA 01588, for a Special Permit (12-SP-18) pursuant to Article X, Section 173-47 Special Permit, 173-12 Table of Use Regulations in order to allow the applicant to open a Tattoo shop at the location of 110 Church Street, Whitinsville, MA 01588. The property, shown on Assessor's Map 14A Parcel 23, is located in a Business-1 zoning district and is owned by Denis LaTour.

A signed to this hearing by the Vice Chairman Bill Corkum, is Randy Kibbe, Cindy Danoti and Damian Planas-Merced. Bill Corkum explained that this must be a unanimous vote to pass and gave the option to postpone and reschedule, Dennis Latour felt comfortable with going forward.

Dennis LaTour spoke and explained to the board that he wanted a special permit to open a Tattoo Shop in his building at 110 Church Street on the second floor. This is an approved use with a Special Permit and would be done by appointment in the evening hours; this will not cause any

approvals and or permits by the State and Federal regulations and assures the board this will be completely professional. Dennis has also assured the board he will be responsible for the hazardous wastes and there will be no issues.

Doug Curving has joined the meeting and has been updated of the previous conversations.

With no more questions, a motion was made by Randy Kibbe to close the public hearing and take it under advisement, Seconded by Damian Planas-Merced the vote 5-0 in favor. The board discussed the Tattoo shop and felt it was good for business in that area it will be professional and legal.

A motion was made by Cindy Donati to approve the special Permit, seconded the motion was Damian Planas-Merced. Vote 5-0 Special Permit approved.
